YOU ARE EXPECTED TO BE OPEN BY OPENING HOURS AND WILL NOT CLOSE BEFORE CLOSING HOURS.

SATURDAY 9:00 AM TO 5:00 PM SUNDAY 9:00 AM TO 3:00 PM

#### SET UP PRIVILEGES ARE:

NOVEMBER 30<sup>th</sup> FRIDAY 7:00 AM TO 5:00 PM DECEMBER 1<sup>st</sup> SATURDAY 8:00 AM TO 9:00AM DECEMBER 2<sup>nd</sup> SUNDAY 8:00AM TO 9:00AM

- 1. Table covers are required and booth must consist of 90% vintage merchandise. You will be asked to remove unacceptable merchandise from your booth.
- 2. Dealers may drive in for unloading during non public hours only, driving permitted on arena area only. Absolutely no driving on the concrete when unloading/loading and no vehicles will be allowed inside the building during public hours.

During set up hours on Saturday and Sunday, dealers will enter and exit through door #1 at the North West end of the building.

- 3. Vendors are to park on the West side of building. Do not park trailers next to the building; trailers must be parked at the South end of building.
- 4. There will be no selling out of trailers inside of the building.
- 5. There will be no selling of beverages or food.
- 6. Portable heaters, whether electric or gas/kerosene will not be allowed.
- 7. Light bulbs used shall be of low wattage -40 watts or less.
- 8. Management expects to receive cancellation notice by the Friday prior to the show.
- 9. <u>Gordyville is a non-smoking facility</u>. If you need to smoke please step outside. The Department of Health demands that this policy be enforced.
